Incident Investigations

Conducting a quality investigation to reduce risk

As a safety professional, we constantly strive to prevent work-related injuries and illnesses caused by occupational hazards. Although the objective is to eliminate all injuries and illnesses associated within our distinguished industries, we must take the opportunity to conduct a thorough investigation when an incident occurs in the workplace. Performing a root cause analyze will uncover contributing factors, permitting the development of innovative solutions and hazard mitigation techniques. Thus, allowing us to implement corrective actions to reduce the risk associated with work-related procedures and limiting the possibility of similar occupational incidents.

Steps in an Investigation Process:

In getting started, remind everyone involved, especially workers, the investigation is to learn and prevent, not find fault.

1. Call or gather the necessary person(s) to conduct the investigation and obtain the investigation kit.
2. Secure the area where the injury occurred and preserve the work area as it is.
3. Identify and gather witnesses to the injury event.
4. Interview the involved worker.
5. Interview all witnesses.
6. Document the scene of the injury through photos or videos.
7. Complete the investigation report, including determination of what caused the incident and what corrective actions will prevent recurrences.
8. Use results to improve the injury and illness prevention program to better identify and control hazards before they result in incidents.
9. Ensure follow-up on completion of corrective actions.

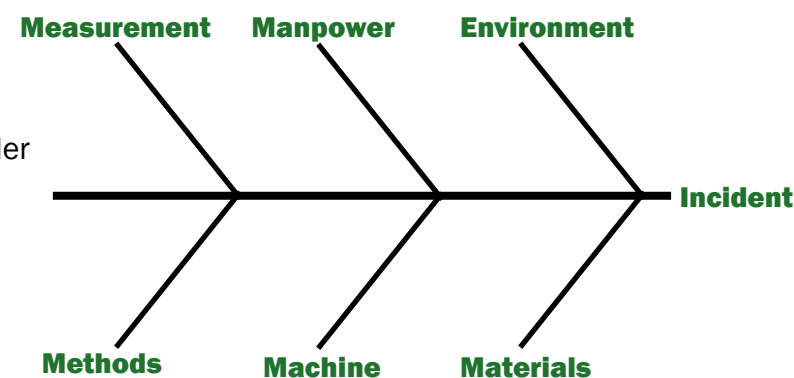
Who is involved:

- **Injured worker's supervisor**
 - The individual(s) who oversee the daily operations of the injured worker.
 - Ex. Superintendent, Foreman, Captain, Floor Manager, Operations Supervisor, etc.
- **Safety team**
 - Company appointed division dedicated to managing safe operations in the workplace.
 - Safety Manager, Site Safety Manager, Fire Safety Manager, Review Committee, Safety Practitioner, etc.
 - In severe cases, Senior Management, Executives, Engineering Staff, Legal Counsel, etc.
- **Witnesses**
 - Bystanders to the incident or events preceding such as co-workers, partners, supervisors, etc.
 - Workers participating in similar operations to the injured employee may be helpful in explaining routine procedures of the task performed.
- **Injured Employee**
 - Employee who obtained the injury due to work-related procedures
 - May request employee representative during investigation

What to have on hand:

Ensure you have a prepared investigation kit ahead of time.

- Investigation forms
- Interview forms
- Barricade markers/tape
- Warning tags or padlocks
- Flashlight
- Camera or video recorder
- PPE
- A pen
- Voice recorder
- Measuring tape
- Sample containers



Information to collect:

- **Worker characteristics:**
 - Age, gender, department, job title, experience level, tenure in company and job, training records, orientation records, and type of contract (Full-time, part-time, seasonal).
- **Injury characteristics:**
 - Describe the injury or illness, part(s) of body affected, and degree of severity.
 - In the case there is an on-site medic, it may be helpful to communicate with them about the injuries and treatment received by the employee.
- **Narrative description and sequencing of events:**
 - Location of incident and nature of the work environment
 - Complete sequence of events leading up to the injury or near miss
 - Objects, equipment, or substances involved in event
- **Characteristics of equipment associated with incident:**
 - Type, brand, size, distinguishing features, condition, specific part involved, correct accessories used, guards in place, etc.
- **Characteristics of the task being performed when incident occurred:**
 - General task, specific activity, posture, and location of injured worker, working alone or with others
- **Time factors:**
 - Time of day, hour in injured worker's shift, type of shift, phase of worker's day such as performing work, break time, mealtime, overtime, or entering/leaving facility
- **Supervision information:**
 - Was the injured worker was being supervised directly, indirectly, or not at all and whether supervision was feasible?
- **Corrective actions:**
 - Immediate measures taken, interim or long-term actions necessary.
