
Assessing Personal Protective Equipment


As EHS professionals, whether consulting or working in industry, managing employee exposure to hazards is a significant portion of the requirements of the job. Hazards employees are exposed to can be routine or novel, high or low severity, part of simple or complex systems. And while OSHA's Hierarchy of Controls dictates the prioritized approaches EHS professionals are expected to use, at some point the only process standing between an employee and exposure to a hazard will be the proper application and use of Personal Protection Equipment (PPE). But how often have you, the EHS professional, been part of a conversation that has included statements such as "I bought this gear because that is what I did at an old job", "I was just told to use this", or "I'm not sure why this chemical is dangerous, I just use it". Managing a PPE program and assisting the employees who use it is an ongoing process that requires attention beyond the initial purchase of equipment.

OSHA regulations contain several specific requirements under Subpart I for the implementation and use of selected PPE, including:

- Eye / Face protection;
- Respiratory protection;
- Head protection;
- Foot protection;
- Hand protection;
- Fall protection systems; and
- Protection from electrical hazards.







Additionally, the General Duty Clause gives EHS professionals the requirement to manage PPE for other types of hazards not explicitly described in this subpart, such as chemical splashes to the body or radio frequency exposure. It is up to the EHS professional to systematically assess job tasks in a workspace, inform affected employees on the results of the assessment, monitor ongoing performance/usage, and be aware of potential changes that could require reassessment of a job task. As with many assessment requirements, it is up to the EHS professional to design the system that best fits their needs, however documenting PPE assessments will likely require some kind of matrix to display the job tasks evaluated, the hazards identified, and the PPE assigned to the job task. Note here, I have written PPE assigned to the job task, not PPE assigned to the worker; one employee may need to change the PPE they utilize through the course of their work shift if they conduct different job tasks with different assessed hazards. An effective job task assessment can include a task designation/title, a description of the work being conducted, and a statement describing the risk of exposure to hazards for each PPE type (see the list above for examples). It is just as important to describe why a particular hazard exposure does not require PPE as those which do so that future adjustments to job descriptions can be more effectively assessed for new/modified PPE requirements.

Finally, educating employees on the PPE requirements of the job tasks they conduct is vital to the successful implementation of a PPE program. Explaining what the hazards of the job tasks are, how PPE fits into the overall safety program, where they can obtain PPE, how to properly use it, and who to go to with questions or concerns needs to presented in a way so that the employee understands what you are asking of them and their responsibilities under the program. Ongoing employee education is critical to prevent employees cutting corners with PPE usage, and it also gives an opportunity for employees to discuss PPE usage with you and identify potential scenarios where job tasks were modified without your knowledge.
