# **Hoist Dismantle Pre-Planning Checklist**

Hoist dismantle operations are an inevitable high-risk event occurring on commercial construction sites. Throughout the past couple of months, the Turner Construction Field Staff at 181 Mercer has been establishing a systematize approach for hoist dismantle pre-planning & operation procedures. The goal is to develop a standardized approach to dismantling a hoist, allowing other safety professionals to utilize the strategies as a guideline on their own sites.

181 Mercer is a New York University campus building consisting of seven hundred and fifty thousand square feet. 181 Mercer began dismantling the exterior hoist on February 23rd, 2022. As a result of our preplanning efforts, our trade partner was able to dismantle our three hoists on schedule and without incident.

All projects are particularly different in size, layout, and function. Also, various trade partners are contracted to complete these operations across the nation. Nonetheless, there will always be specific items in the pre-planning process that remain consistent.

The following action items can be used as a baseline for pre-planning your hoist dismantle with safety initiatives:


#### **Action Item 1: Provide a List of Items the Trade Partner Needs to Prepare Before Pull Meeting**

#### Who:

 General Contractor: Elevator Superintendent, Site Safety Manager, Site Super, etc. to develop a list of items the trade partner needs to prepare before the Pull Plan.

#### When:

- Send to trade partner at least 1 week before Pull Plan Meeting What:
- Equipment Specs. All equipment being used MUST match specs.
  - Vertical Lifelines, Harnesses, D-Rings, Rope Grabs, SRL, Etc.
- Logistics Plan
  - GC Elevator Superintendent to provide most up-to-date logistics plan to trade partner
  - Area of CAZ, Dumpster Placement, Truck Placement, Knuckle Boom Placement, Etc.
- Fall Protection Plan
  - Anchorage points identified, stamped engineer drawing showing tie-off points (ie. common platform landing, common platform leg, structural column member, etc.), drawing(s) of knot type, etc.
- Rescue Plan
  - If someone falls, how will they be rescued? (ie. backboard, additional lanyard kept in hoist car, etc.)
- Site Specific JHA
- **Competent Person Identified**



#### Action Item 2: Schedule Pull-Plan with Hoist Trade Partners and All Other **Relevant Individuals**

#### Who:

- General Contractor: Site Safety Manager, Site Superintendent, Elevator Superintendent, Envelope Superintendent, etc.
- Other: Temp. Carpenter Foreman, Temp. Electric Foreman, Curtain Wall Foreman, Demo Foreman, etc. When:
- 4 weeks prior to Hoist Dismantle

 Consistently update & communicate with trade partner until dismantle. What:

\* Important Note: Document all meeting minutes and sent to all parties involved in meeting

- Review Project Logistics Plan:
- Discuss & document any changes needed to be made to the logistic plan.
- Specs for Equipment All equipment being used MUST match specs.
  - Ensure all necessary specs. are provided by subcontractor.
  - If any specs, are missing, inform trade partner of what needs to be provided.
  - Remind your trade partner that the specs. provide MUST match the equipment used.
  - List/document any specs. that are missing.
- Review Fall Protection Plan
- Discuss & document any changes needed to be made to the fall protection plan.
- Review Tie-Off Anchorage Points
  - Discuss & document any changes needed to be made to anchorage points.
- Review Rescue Plan
  - Discuss & document any changes needed to be made to rescue plan.
- Review JHA
  - Discuss & document any changes needed to be made to JHA.
- Review Past Incidents (if applicable)
  - How can we avoid a similar incident from occurring?
  - Document in meeting minutes.
- Discussion of safety expectations
  - Daily PTP submitted to elevator superintendent
  - Daily fall protection inspections submitted to elevator superintendent.
- List of manpower
  - · Confirm all manpower has received site specific safety orientation
  - Is refresher orientation needed for manpower?
  - Document of manpower certifications
- Discussion of work hours
  - Timeframe and expectations of what is going to be accomplished per day.
  - Engineer approval of when hoist dismantle operations can end for the day
- Discussion of General Contractor/Temp. Carpenter Prep Items

#### **Action Item 3: Notify Project of Hoist Dismantle and Share Logistics Plan** Who:

- Project/Site Superintendent or Site Safety Manager When:
- First Notification: 2 weeks before dismantle
- Second Notification: 1 week before dismantle
- Discussed at weekly foreman/safety meeting if applicable What:

- Email all foreman the updated logistics plan and share during foreman/safety meeting
- Print logistics plan and store in binder for documentation.

Trade Partner: Owner/Principle, Safety Representative, Engineer (if needed), Foreman/Crew Lead(s), etc.

• Signage, site preparation, hoist platform clear of materials/debris, safety netting prepped on platform, etc.

#### **Action Item 5: Follow-up Pull Meeting**

#### Who:

Anyone involved at first pull meeting

#### When:

• One week before dismantle

#### What:

- Discuss any necessary updates documented during first pull-meeting
- · All necessary updates need to be made before dismantle of hoist

#### **Action Item 6: Prep Items Completed**

#### Who:

Anyone assigned preparation items in pull initial pull meeting

#### When:

• All prep items should be completed 2 days prior to start date.

#### What:

- Signage:
  - Posted on hoist platform doors ٠
  - Signage should read: DO NOT ENTER Hoist dismantle in progress.
  - In case of fire emergency, do not lock platform doors
- Fire Extinguishers:
  - Safety Team or Fire Safety Manager ensure emergency fire extinguishers located outside hoist platform
  - Ensure COFs are charged, tagged, and inspected.
- Site Prep:
  - Flat and level service for all dumpsters, trucks, etc.
  - Ensure staging areas identified are clear of other equipment or debris
  - Use orange cones, yellow chain/flags, and signage to create a controlled access zone.
  - Set up trucks, dumpster, and other equipment specified in logistics plan
  - Safety netting installed on hoist.
  - All hoist platforms cleared of material/debris
  - Temp. Carpenter to install excess safety netting at hoist platforms. This makes it easier to reapply safety netting when hoist platforms and ramps are removed.

### **Action Item 6: Pre-Dismantle Meeting**

#### Who:

- Trade Partner: Entire crew, Safety Representative, Foreman/Crew Lead
- Turner: Site Safety Manager, Elevator Superintendent, etc.

#### When:

Morning when dismantle begins

#### What:

- Trade Partner Safety Representative & Foreman to review JHA, Fall Protection Plan, and Rescue Plan with entire crew
- Orientation/Reorientation for manpower by General Contractor Safety Team.
- Document who attended meeting with sign-in sheet 6
