## **October 29th Technical Meeting:**

## ANSI/ASSP Z244.1 The Control of Hazardous Energy Lockout, Tagout and Alternative Methods

Machinery accidents are among the most common severe injury/fatality (SIF) incidents in industry. Z244.1 is the most recognized consensus standard for lockout/tagout when servicing or maintaining equipment. In this session, Peter Noddin will discuss the current 202X proposed revisions to the standard, focusing on differences from the 2016 version. We will also discuss the relationship between this standard and OSHA's Control of Hazardous Energy standard, the well-defined boundary between machine guarding and lockout, as well as applicability and potential pitfalls of alternative procedures.

Peter Noddin, CSP, OHST, has been a Professional Member of ASSE/ASSP since 1996 and has a career spanning nearly 40 years in safety and health. This includes facility safety in forest products manufacturing, as well as nearly 20 years as a consultant. He is a current voting member of the ANSI/ASSP Z244.1 Standard Committee and is often retained as an expert witness in machinery accident, fire/explosion and public safety cases around the country. He currently serves as Health and Safety Manager for Monadnock Paper Mills in Bennington NH.
